No. G.S.R. 93/Const./Art.309/Amd.(2)/2021.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab Educational (Teaching Cadre) Group 'C' Service Rules, 2018, namely: -

RULES

1. (1) These rules may be called the Punjab Educational (Teaching Cadre) Group 'C' Service (First Amendment) Rules, 2021.
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab Educational (Teaching Cadre) Group 'C' Service Rules, 2018, in Appendix 'B', against serial No.12, under column No.5, for the existing entries, the following entries shall be substituted, namely:-
 - " (i) Should have passed Graduation atleast with 55 percent marks from a recognized university or institution with Fine Arts as a subject having studied atleast for three years in Graduation as per the guidelines of the University Grants Commission; and
 - (ii) Should have passed B.Ed. from a recognized university or institution with Fine Arts as one of the teaching subjects as per guidelines of the University Grants Commission.

OR

- (i) Should have passed Graduation atleast with 55 percent marks from a recognised university or institution as per the guidelines of the University Grants Commission;

(ii) Should have passed B.Ed from any recognised university or institution as per guidelines of the University Grants Commission; and

(iii) Should have passed Two Years' Diploma in Art and Craft Teachers from a recognized university, Board or institution as per guidelines of the University Grants Commission".

No. G.S.R. 94/Const./Art.309/Amd.(2)/2021.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules, further to amend the Punjab Educational (Teaching Cadre) Border Area Group 'C' Service Rules, 2018, namely: -

RULES

1. (1) These rules may be called the Punjab Educational (Teaching Cadre) Border Area Group 'C' Service (First Amendment) Rules, 2021.
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab Educational (Teaching Cadre) Border Area Group 'C' Service Rules, 2018, in Appendix 'B', against serial No. 12, under column No.5, for the existing entries, the following entries shall be substituted, namely:-

" (i) Should have passed Graduation atleast with 55 percent marks from a recognized university or institution with Fine Arts as a subject having been studied atleast for three years in Graduation as per the guidelines of the University Grants Commission; and

(ii) Should have passed B.Ed. from a recognized university or institution with Fine Arts as one of the teaching subjects as per the guidelines of the University Grants Commission.

OR

(i) Should have passed Graduation atleast with 55 percent marks from a recognised university or institution as per the guidelines of the University Grants Commission;

- (ii) Should have passed B.Ed from any recognised university or institution as per the guidelines of University Grants Commission; and
- (iii) Should have passed Two Years' Diploma in Art and Craft Teachers from a recognised university, Board or institution as per the guidelines of the University Grants Commission."
